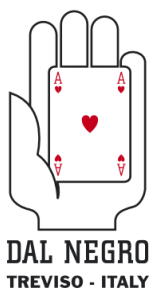

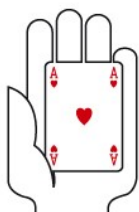

INFORMATIVE LETTER IN CONFORMITY WITH ARTICLE 13 OF LEGISLATIVE DECREE 196/2003

“Code regarding the protection of personal data”

In conformity with Article 13 of Legislative Decree 196/03 – the code of laws regarding the protection of personal data – “Teodomiro Dal Negro spa con unico socio” is obliged to supply certain information (Article 13) concerning the use of your personal data.

The data that our company possesses are collected directly from the person concerned, as well as acquired from third parties, such as from data processing centers and archives, including public data processing centers and archives.

To this end the following informative letter includes the elements that qualify how such data is handled.

The information that our company already possesses or that it may acquire in the future shall in all cases be handled in strict conformity with the aforementioned Code and with the confidentiality obligations contained in such Code.

1. PURPOSE AND METHOD OF DATA HANDLING

Any personal data, notified to or acquired by our company, shall be used within the area of the execution of activities of “Teodomiro Dal Negro spa con unico socio” for the following purposes:

- Management of existing business and contract relationships, in pre-contract stage.
- Management of any contract relationships that may be established in the future, including the management litigation with particular reference to credit safeguarding.
- Fulfillment of the legal obligations deriving from existing relationships.
- Execution and development of institutional activities, involving, for example, the processing of statistics or marketing activities.

The data shall be handled in writing and/or paper files, magnetic and electronic means and computer systems.

The data shall be used for the fulfillment of all the obligations of the law for the entire term of the contract relationship, and even subsequently. The person concerned may, at any time, request that his/her personal data be cancelled from the archives as indicated in point 5 below.

2. COMMUNICATIONS AREA

In addition to communication and transmission carried out in compliance with the obligations of the law and contract obligations, the data may be transmitted in Italy and abroad for the purposes stated above to the following entities:

- Our sales representative network
- Carriers for transport
- Law firms
- Credit institutes and other financial brokers, for any obligations connected with the contract relationship
- Professional persons, corporate bodies and consultants, for the fulfillment of obligations imposed by the law.
- Controlling, controlled and associated companies.

3. SUPPLY OF DATA

It is mandatory to supply the data required for the fulfillment of legal and tax obligations deriving from existing contract and business relationships.

4. REFUSAL TO SUPPLY DATA

The refusal to supply data as point 3) above, or the subsequent refusal to consent to the handling of such data, shall make it impossible for the writer to carry on the existing business or contact relationships.

The refusal instead to supply any requested data that do not regard contract or legal obligations shall be evaluated by the writer on a time to time basis and such refusal shall influence the subsequent decisions taken by the writer based on the importance that such requested and non-supplied data has for the writer.

5. RIGHTS OF THE PERSON CONCERNED

With regards to data supplied, the person concerned may exercise the rights stipulated in article 7 of the Code, namely:

Art. 7. Right to access personal data and other rights

1. The person concerned has the right to obtain confirmation as to whether or not personal data concerning him/her exist, regardless of their being already recorded, and communication of such data in intelligible form.
2. The person concerned has the right to be informed of: a) the source of the personal data; b) the purposes and methods of the handling; c) the logic applied to the handling if the latter is carried out with the aid of electronic means; d) identification data concerning data controller, data processors and the representative designated as per 5 (2); e) the entities or categories of entities to whom or which the data may be communicated and who or which may become acquainted with said data in their capacity of designated representative in the territory of the State, data processors or persons in charge of the handling.
3. The person concerned has the right to obtain: a) the updating, rectification, or whenever required, the integration of the data.; b) cancellation, anonymizing or blocking of data that have been handled unlawfully, including data whose retention is unnecessary for the for the purposes for which they have been collected or subsequently handled c) certification to the effect that the operations as per letters a) and b) have been notified, also as related to their contents, to the entities to whom or which the data were communicated or divulged, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.
4. The person concerned has the right to object, in whole or in part: a) on legitimate grounds, to the handling of personal data concerning him/her, even if they are relevant to the purpose of the collection; b) to the handling of personal data concerning him/her, where it is carried out for the purpose of forwarding advertising materials, direct selling or carrying out market researches or commercial communication surveys.

6. DATA HANDLING CONTROLLER
